### **IMPORTANT NOTICE**

If a hearing is set on your Motion, the Notice of Hearing must be mailed to the opposing party at least twenty days before the hearing is held.

#### **Complete this form by:**

- ☐ Complete the caption by filling in the county name, judicial circuit number, Plaintiff and Defendant name, and file number. All of this can be found on any previous filing completed in your case. Leave the remainder of the form blank for the Court to fill out.
  - You can also contact the Clerk of Court, legal help line, or email UJS staff for this information.
- ☐ File the original copies of the Notice of Hearing (UJS-336), Motion (UJS-335), Affidavit in Support (UJS-337), if you completed one, and any supporting documents with the Clerk of Court. Remember to retain copies for your records.
- ☐ The Court will provide you with a completed Notice of Hearing (UJS-336) which will set the date, time, and location of the hearing.
- ☐ Mail copies of the Notice of Hearing (UJS-336), Motion and Request for Hearing (UJS-335), and Affidavit in Support (UJS-337), if you complete one, and any supporting documents to the opposing party at least twenty days before the hearing.
- ☐ Complete an Affidavit of Mailing (UJS-338) and file with the Clerk of Court.
